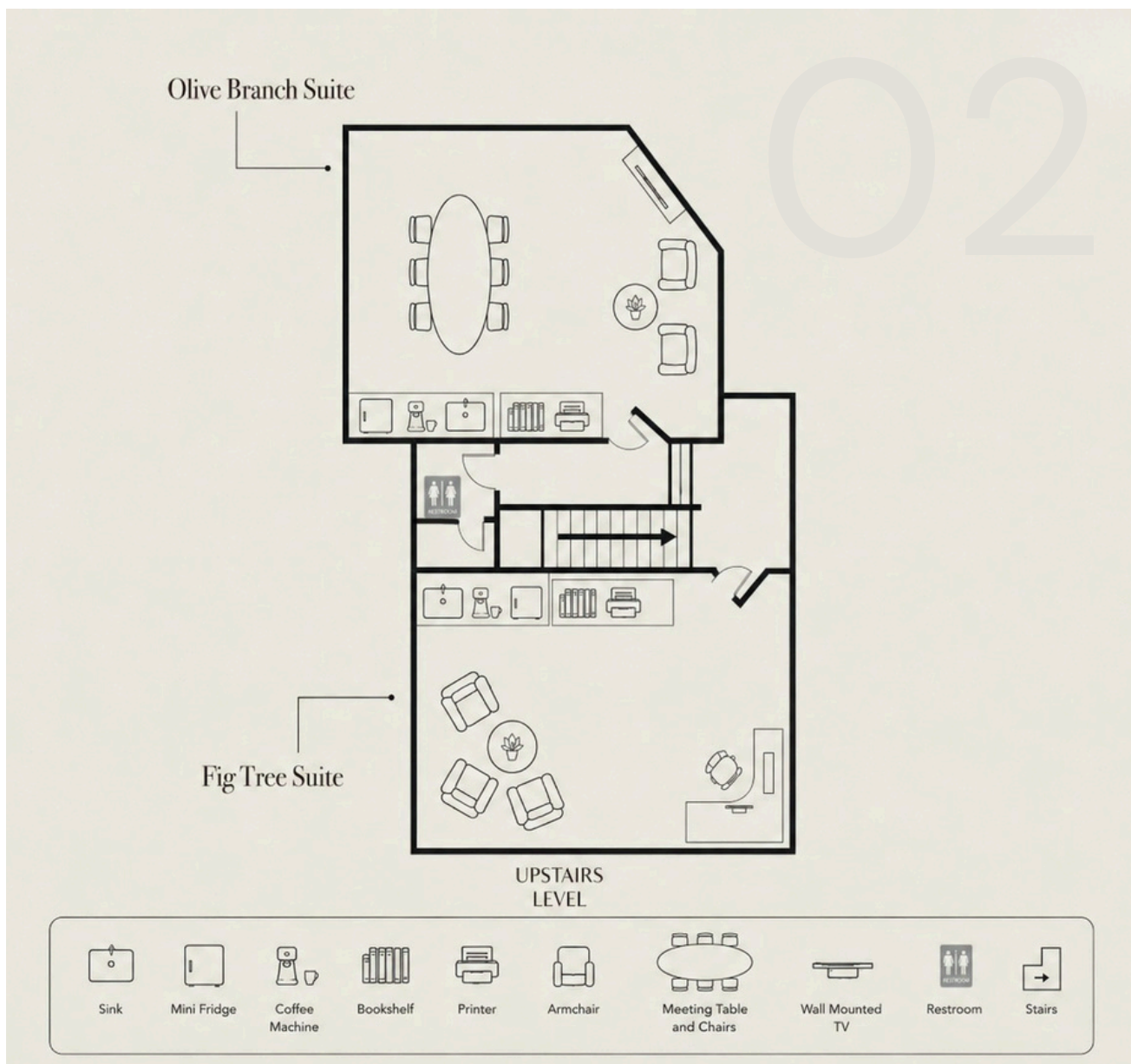


Welcome to The Resolution Suites

A specialist professional venue in the heart of Strathpine, created for the particular needs of family law and therapeutic work.

The Resolution Suites brings together privacy, thoughtful preparation and professional functionality across two distinct suites — providing practitioners and service organisations with a calm, flexible environment for specialist work.

Available to independent practitioners and organisations across Moreton Bay and Brisbane North.



The Venue

Two private suites. One flexible professional environment.

The Resolution Suites comprises two distinct spaces — Fig Tree Suite and Olive Branch Suite — each available to book independently for private professional appointments.

For matters requiring additional space, physical separation or coordinated use of multiple environments, both suites can be reserved together as The Canopy, providing exclusive use of the full venue.

FIG TREE SUITE

A flexible, softly furnished suite suited to child, family and therapeutic work.

OLIVE BRANCH SUITE

A generous professional suite for mediation, interviews, meetings and therapeutic work.

THE CANOPY

Both suites together, providing exclusive use of the venue for matters requiring multiple spaces or separation.

Olive Branch Suite

A generous, adaptable setting for professional and therapeutic work.

Designed to accommodate both structured and more conversational ways of working, Olive Branch Suite brings together a six-person meeting table and a separate lounge setting within one private suite.

The suite is suited to mediation, family report interviews, therapeutic family work, professional meetings and conferences, with preparations available to support the needs of each appointment.

Designed for appointments that benefit from a softer, less formal environment, Fig Tree Suite combines comfortable lounge seating with flexible space for play, conversation and professional work.

The suite is suited to child consultations, family report interviews, therapeutic appointments and supervised child contact, with preparations available for young children, adolescents and individual professional appointments.

The Canopy

Two private suites. One coordinated professional environment.

The Canopy brings Fig Tree and Olive Branch together under one booking, providing exclusive use of The Resolution Suites for matters requiring additional space, privacy or physical separation.

With two distinct environments available throughout the booking, practitioners can move between suites while participants remain comfortably separated — supporting shuttle mediation, family report assessments, child-inclusive processes and therapeutic family work.

The Canopy can also support matters involving multiple family members, practitioners or stages of work, with each suite prepared to support the appointment.

Prepared for individual and family assessment processes.

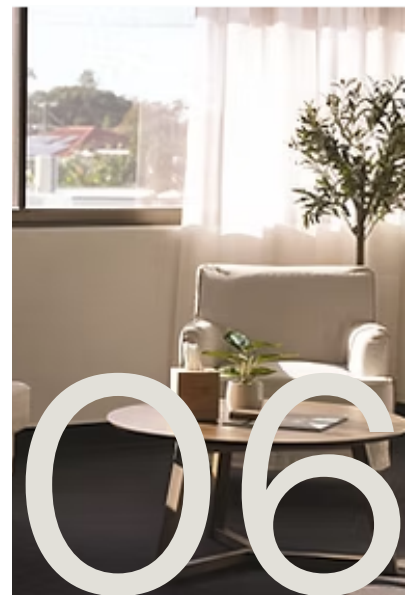
THERAPEUTIC/FAMILY WORK

The Resolution Suites has been designed around the practical realities of sensitive professional work — from arrival and access through to privacy, technology and the everyday details needed throughout an appointment

PRIVATE ARRIVAL

Two reserved parking bays, with access to the private upstairs venue.

SEPARATE SPACES

Two distinct private suites allow participants to remain physically separated where required, without a shared waiting room.

CONTROLLED ACCESS

Time-limited practitioner access and separate client access can be arranged around each booking.

PRIVATE AMENITIES

Private bathroom facilities and in-suite kitchenettes allow practitioners and participants to remain within the venue throughout longer appointments.

CONNECTED & EQUIPPED

Wi-Fi, Smart TVs, climate control and optional printing support professional work throughout the booking.

PREPARED BEFORE ARRIVAL

Your selected suite configuration and preparation are completed before your booking begins.

CATERING OPTIONS

Optional catering can be arranged in advance for practitioners and participants.

Booking options

Flexible access, without the commitment of permanent premises.

The Resolution Suites can be booked by independent practitioners and service organisations as required, with weekday and weekend options designed around different types of professional work.

WEEKDAYS

Half-day · Full-day

Suited to mediation, family report assessments, child consultations, therapeutic work and other appointments requiring extended use of the suite.

WEEKENDS

Hourly · 30-minute increments

Flexible hourly access for supervised child contact, therapeutic appointments and other shorter-form work.

BOOK ONE SUITE

Choose Fig Tree or Olive Branch for private use throughout your booking.

BOOK THE CANOPY

Reserve both suites together for exclusive use of The Resolution Suites where additional space or physical separation is required.

Suite Preparations are included with every booking at no additional charge.

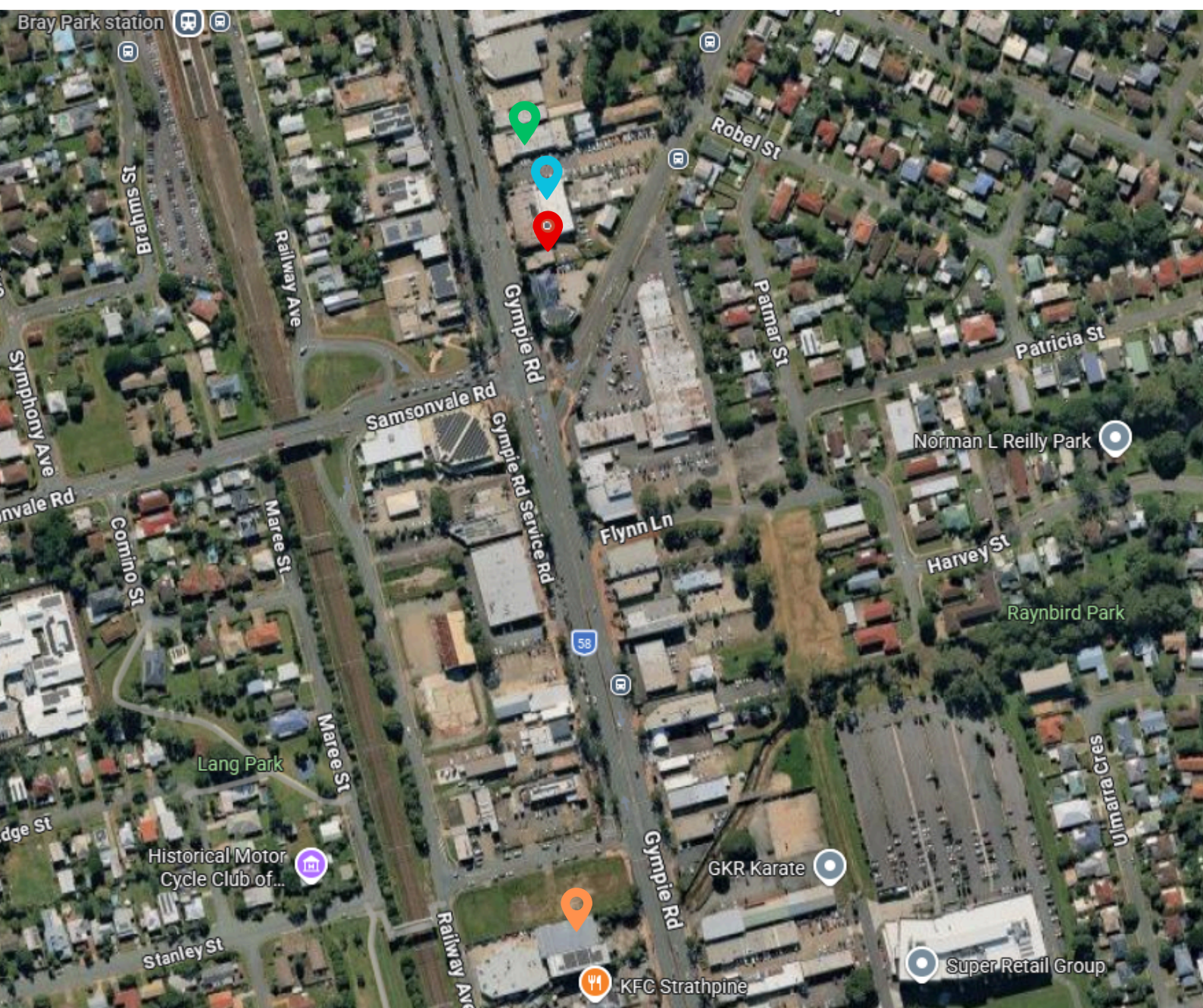
